BOND RESOLUTION DATED JULY 5, 2011, AUTHORIZING THE ISSUANCE OF \$332,000.00 SERIAL BONDS BY THE BOLIVAR-RICHBURG CENTRAL SCHOOL DISTRICT, ALLEGANY COUNTY, NEW YORK, PURSUANT TO THE LOCAL FINANCE LAW TO FINANCE THE PURCHASE OF TWO (2) 2012 THOMAS MODEL 310TS SEVENTY (70) PASSENGER SCHOOL BUSES AND TWO (2) 2012 IC BUS MODEL PB405 BE1902 THIRTY (30) PASSENGER SCHOOL BUSES.

WHEREAS, the Board of Education of the Bolivar-Richburg Central School District, Allegany County, New York, by resolution duly adopted by the Board of Education on April 5, 2011 and approved by the voters of the Bolivar-Richburg Central School District on May 17, 2011, authorizing the purchase of Two (2) 2012 Thomas Model 310TS Seventy Passenger School Buses and Two (2) 2012 IC Bus Model PB405 BE1902 Thirty Passenger School Buses for use by said School District, said buses to be purchased at a total price of \$359,070.70 and

WHEREAS, it is now desired to provide for the financing of said buses,

NOW, THEREFORE, BE IT RESOLVED AS FOLLOWS:

- 1. The purchase of Two (2) 2012 Thomas Model 310TS Seventy Passenger School Buses and Two (2) 2012 IC Bus Model PB405 BE1902 Thirty Passenger School Buses is hereby authorized at a maximum cost of \$332,881.83.
- 2. The plan for the financing of said buses is by the trade in of buses numbered 22 and 23 for a credit of \$9,000.00, a discount of \$88.87, and by the trade in of buses numbered 27 and 29 for a credit of \$17,100.00, payment of \$881.83 from current budget appropriations, and the issuance of up to \$332,000.00 serial bonds of said School District, pursuant to the Local Finance Law, which bonds are hereby authorized therefore; further details pertaining to said bonds, if necessary, may be prescribed in another resolution or resolutions of this board.
- 3. Subject to the provisions of the Local Finance Law, the power to authorize the issuance of and to sell bond anticipation notes in anticipation of the issuance and sale of bonds herein authorized, including renewals of said notes, is hereby delegated to the President of said Board of Education, the chief fiscal officer. Said notes shall be of such terms, form and contents, and shall be sold in such manner, as may be prescribed by said President, consistent with the provisions of the Local Finance Law.
- 4. It is hereby determined that the period of the probable usefulness of the aforesaid object or purpose is five years, pursuant to subdivision 29 of paragraph A of Section 11.00 of the Local Finance Law, and the said bonds will mature over a period not in excess of five years.
- 5. The faith and credit of said Bolivar-Richburg Central School District, Allegany County, New York are hereby irrevocably pledged for the payment of the principal of and interest on said bonds as the same respectively becomes due and payable.
- 6. The bonds hereby authorized are declared to be "exempt bonds" under the provisions of the Internal Revenue Code of 1986 inasmuch as the Bolivar-Richburg Central School District will not issue more than \$10,000,000.00 of bonds during the year of issue.
- 7. The validity of such bonds or notes or any bond anticipation notes issued in anticipation of the sale of such bonds may be contested only if:

- i. Such obligations are authorized for an object or purpose for which the municipality, school district or district corporation is not authorized to expend money, or
- ii. The provisions of law which should be complied with at the date of the publication of such resolution or summary thereof, or certificate, as the case may be, are not substantially complied with, and an action, suit or proceeding contesting such validity, is commenced within twenty (20) days after the date of such publication, or
 - iii. Such obligations are authorized in violation of the provisions of the constitution.

RESOLVED, the Bolivar-Richburg Central School District shall act as the lead agency for the purposes of the required State Environmental Quality Review Act (SEQRA).
